- Sub. :-** Procedure of Reduction in Contract Demand/ Sanctioned Load in accordance with MERC (Electricity Code and other conditions of supply) Regulations, 2005  
– Delegation of powers thereof.  
-- Corrigendum to Commercial Circular no. 101 dt. 16.10.2009.

The procedure of Reduction in Contract Demand / Sanctioned Load is communicated to field officers vide Commercial Circular no. 101 dt 16.10.2009. The delegation of powers are conveyed vide clause no.3 of the said Circular. The table given in clause no.3 of the said Circular reveals as under.

Sr. No.	Delegation of Powers to the Authorities for reduction in Contract Demand	Consumers having Existing Loads as below and applied for reduction in contract demand
1.	E.E.s. of O&M Divisions in consultation with J.M. (F&A)	a) LT consumer's with sanctioned Load upto 107 HP in all areas except Municipal Corporation area. b) LT consumer's with sanctioned Load upto 201 HP in Municipal Corporation area
2.	S.E.'s of O&M Circle in consultation with Dy. M (F&A)/ A.M. (F&A)	HT Consumer's upto and inclusive 5 MVA
3.	C.E.'s of O&M Zones in consultation with Manager (F&A)/ Dy. M. (F&A)	HT Consumer's above 5 MVA & upto and inclusive 10 MVA
4.	Dir. (Operation) in consultation with Dir. (Finance)	HT Consumer's above 10 MVA
